- She mentioned that Penrose Library is a net lender and the changes there may impact this area. Also the survey data won't reflect the closing of the Denver Health Medical Library.
- Glenn Pflum stated that the Swedish library has seen their OCLC requests double or triple recently.
- Sara Katsh said that staffing levels have a lot to do with being able to handle reciprocal borrowing.
- Margaret said that it might be necessary to charge for reciprocal borrowing to increase its
  value in the eyes of those who are using it and demonstrate that it is not really free. The costs
  may be hidden, but someone is always paying for the service.
- Connie Baker said that more staff time is involved if there is a charge.

The question came up about what qualifications are necessary for a library to join Docline. A library must have a minimum of 25 journals in the collection in Serhold and a staff of .20 FTE.
