## Membership committee

Membership committee consisted of Ben Harnke as Chair and Melissa Kovac as member.

As of 4/14/2016 the Colorado Council of Medical Librarians has 87 members. This membership can be broken down into the following categories: 66 regular members; 17 emeritus members and 4 student members.
